Mattioli Woods MWPortal Terms of Use

1. About these Terms of Use

- 1.1 The below terms (the "Terms") apply to you when you use the Mattioli Woods MWPortal (the "MWPortal"). The MWPortal is an online service providing you with access to view the value and transactions associated with your investments held with Mattioli Woods plc.
- 1.2 The Terms are a legal agreement between you and Mattioli Woods plc ("MTW", "Us", "We", "Our") that outlines the latest version of the standardised Terms of use presented to users of the MWPortal. These Terms of use must be read in conjunction with any other applicable terms and warnings governing the use of this MWPortal.
- 1.3 We are authorised and regulated by the Financial Conduct Authority under firm number 220743. We are a public listed company and are registered in England and Wales with registration number 3140521. Our registered address is 1 New Walk Place, Leicester, LE1 6RU.
- 1.4 These Terms govern your use of the MWPortal, therefore please read these Terms carefully and do not use the MWPortal if you do not agree with them.
- 1.5 By accessing or using the MWPortal you confirm you have read, understand, and agree to be legally bound by these Terms. If you do not agree to these Terms, please do not access, or use the MWPortal.

2. Access and use of the MWPortal.

- 2.1 In order to be able to access the information offered on this MWPortal, you may need to use a specific user ID, email address or other login information, such as a password ("Login Information"). You must not disclose your Login Information to any person or otherwise allow any person to access the MWPortal using your Login Information.
- 2.2 Any person(s) granted express permission to access the MWPortal must do so exclusively for the purpose intended. This includes, but may be limited at times due to development work being undertaken:

- c) the security of information transmitted over the internet, and you understand that We do not guarantee any confidentiality with respect to any account details or content you upload, create, store and/or otherwise use in relation to the Portal.
- d) the MWPortal will always be available and accessible
- e) the MWPortal will not be revoked/removed
- 4.3 We do not make any other warranty or guarantee in respect of the MWPortal or your use of it.

5. Your Responsibility

- 5.1 You shall ensure that:
 - a) Your equipment and software is used in such a manner as will not adversely affect or corrupt the MWPortal software or any other software which may be used by MTW,
 - b) Your equipment and software is not used to access or retrieve any data which you are not entitled to access,
 - c) you do not use the MWPortal or permit it to be used in any way that causes the MWPortal or access to it to be interrupted, damaged or impaired in any way,

6. Your account

- 6.1 To use the MWPortal, you are required to have an email address.
- 6.2 We will need to be informed of this email address to create the account. To access your account requires entering a username and password, and additionally, using a mobile phone for multi-factor authentication.
- 6.3 You will first need to complete the first-time access process outlined in the guide sent with your invitation. You confirm that the details you provide to set up your account are accurate and correct. You are solely responsible for your Login Information and must always keep this secure and up to date.
- 6.4 It is your responsibility to keep access to your account secure. You must not:
 - a) allow any other person or entity to access or use your account and you must keep your Login Information confidential and not share them with anyone else,
 - b) access or use (or attempt to access or use) the account belonging to any other user of the MWPortal,
 - c) create (or attempt to create) additional accounts on the MWPortal, or
 - d) create (or attempt to create) an account using false, untrue, or misleading details or using the personal details of another individual.
- 6.5 If you believe that another person or entity has accessed your account, you should notify us immediately on the contact details provided in clause 1. You should also seek to

- notify your IT department to investigate any breach and take steps to change any passwords immediately.
- 6.6 You agree that at any time We may suspend or cancel your MWPortal account if you have breached any of these Terms.

- 14.3 These Terms and all non-contractual obligations connected to them are governed by English law. You and We agree to submit to the non-exclusive jurisdiction of the English courts in respect of the same.
- 14.4 No waiver shall constitute a waiver of any other terms. No failure by us to exercise a remedy shall constitute a waiver to subsequently exercise any remedy.
